## About the Role

Reporting to the Corporate Controller, the Accounting Manager will be responsible for the accounting at both the parent company and certain subsidiaries, assisting in the quarterly close process and working on various ad-hoc projects. We're looking for a team player who has superior communication skills when dealing with individuals both inside and outside the organization. The Accounting Manager will need to have strong attention to detail, be highly organized, have strong analytical skills, and have a passion for leveraging technology.



Core responsibilities will include:

- Lead the month-end accounting process: maintaining accurate books & records for the Playmaker parent company, as well as certain operating companies and assisting in the consolidation process.
- Prepare quarterly public company IFRS financial statements and management discussion and analysis.
- Design and implement internal controls over financial reporting.
- Assist and onboard acquired companies on to our accounting system, our GL format, our budgeting process, our internal control processes, etc.
- Assisting with our consolidated audit and any local entity statutory audits.
- Researching and preparing technical IFRS accounting memos to set technical accounting policies around complex accounting issues like revenue recognition, stock comp, business combinations, etc.
- Assisting with other projects as needed: due diligence on M&A targets, system implementation, investor or shareholder reporting, forecasting, etc.

Must haves: 5 years of relevant experience, a Bachelor degree in accounting/finance/business administration, and an accounting designation (CPA,CA,CMA,CGA).

Strongly preferred: experience with multi-national and multi-currency organizations, experience with various accounting systems, technical IFRS accounting knowledge, experience with M&A and purchase accounting, and accounting firm experience.
